### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Maple City Savings Bank, FSB chooses to share; and whether you can limit this sharing.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • Maple City Savings Bank, FSB does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Maple City Savings Bank, FSB doesn't jointly market.
